Trophy Taker Outdoors Radio Host Lee Cepero, Talks about losing his daughter (620 WDAE/95.3 FM)

Almost 14 years ago my life was perfect. We bought our first house, I was engaged to be married and just 2 weeks after the wedding, I found out I was going to be a father. At first, I was scared to death to bring a child into this world; would I be a good father? I didn't know what to expect, but once I looked into her beautiful eyes, the eyes of my first born just after her birth, it truly brought tears of joy to my eyes. She was a part of me, and I knew I had to do anything to take care of and protect that child.

Caylee Marie Cepero was our world. My wife and I were very protective of her, making sure she was safe, giving Caylee everything she needed, spoiling her, and we loved Caylee with all of our hearts. Even at a young age, you can see how much your child is just like you. Caylee had my attitude but had her mother's looks, and I called her Dawn's mini-me because she was the spitting image of my wife Dawn, with her curly brown hair. She had the biggest brown eyes and everyone who saw us would always comment on what a beautiful child she truly was. She had the greatest personality. We found out in 2003 we were expecting another child; a boy. Our family was getting bigger and 3 months after our son, we were pregnant again, this time another little girl. Life was good.

This is what I have always wanted, a big family, wow it was awesome. I was on top of the world, a nice house, good jobs, lots of friends and a beautiful family. Then in an instant, just 8 months later our lives were changed forever. I will never forget that day. My wife called me on a Thursday and said that the school called and said that Caylee was not feeling well and would I go by and pick her up. I picked up Caylee and took her home. That Friday, she had begun vomiting. We thought it was stomach virus. Saturday, she had stopped vomiting but we still took her to After Hours Pediatrics. They diagnosed it as a Stomach Virus. We let her sleep Sunday except when she wanted to go to church. Her baby brother and sister were being baptized, and Caylee wanted to wear her new dress. Monday morning she looked worse, we took her to her Pediatrician about 9am.

He immediately diagnosed it on sight as Leukemia, Monday, March 7, 2005. We were devastated. He said, "This is not a Death Sentence like it used to be." We were confused and scared because this child was well just prior and never had any abnormal symptoms. He made a quick call and 20 minutes later, we took her to the Children's Hospital. They aspirated blood from her marrow and diagnosed it as ALL with an 80% chance of survival, this was the initial early diagnosis. The next morning the final results came in and it was not ALL, but AML, Acute Myeloid Leukemia and now the prognosis was 40% with Chemo and 65% with a Transplant.

Our whole world seemed to end at that moment. The Oncologist gave us her road map and said it would mean 10 days of Chemo and then more treatments lasting 2 1/2 years and then she may relapse and need a bone marrow transplant and could eventually die. With 20 years + of experience, they had never seen or expected anything like this. Her WBC was 283,000 (hyper leukocytosis). They started Leukopheresis, a treatment that cleans out all unnecessary white blood cells. Her count came down momentarily to 190,000 and then went back up to 220,000 with an hour left of the treatment. Her heart rate was now at almost 200, they had to put a ventilator in and they explained that we could lose her. They had to resuscitate her twice, two minutes and back on Support.

She was not clotting and all of her organs were failing. She was not stable and having a difficult time breathing, she was now hemorrhaging and we were told she probably was not going to make it through the night. We told them to keep trying. We could not fail her. Our priest, Father Rich from St. Catherine's Episcopal Church, was there and he said, "The last bit of love you can give her is to let her go." We knew he was right, so we had to make a decision to let her go before she bled to death.. We could not bear to let that happen to her. So, we told them to disconnect her. She died at 8:13 pm on Tuesday, March 8, 2005.

She was gone forever. I remember waking up in a hospital bed shortly after and did not want to believe it. I don't even remember the ride home. At one point a few days after I told myself she was just gone somewhere else to live and that she would be back. Eventually I realized that wasn't going to happen and that part of me was gone forever. I kept asking why, why not me, take me, what did I do wrong, could have I done something different. We were good parents, we took care of her, protected her but no matter how hard you beg or pray, nothing was going to bring her back.

In November 2004, her class had made cards for Thanksgiving. Caylee's card said she wanted to thank Papa for taking her fishing, mommy for buying her things and Jesus for giving her TV. The last thing she said to us just a couple of hours before she passed was, "Papa, I want to watch TV." We believe that Jesus was there, letting Caylee know He was with her.

There is an 80% or higher divorce rate for parents who have lost a child. My wife and I grieved very differently. She was open to talk about our child and did so often, and I don't and really can't; it is very difficult. I couldn't even look at a picture of Caylee for two years; this caused problems in our marriage and just a little over 4 months after she passed, we argued so badly one night the police were called, and I was arrested. Charges were dropped by the state, as there was no cause.

This was a low point in my life and at the time I didn't really care; I did not want to live, I just wanted the pain to stop and it wouldn't. The first 6 months were shock, a blur. Then one day I found myself sitting on the bed, just staring at the bedroom wall, when my 3 year old son reached out and held my hand; he said nothing, he just looked at me. That was it; that was when it hit me; Caylee wanted me to focus on the two other children we had. After that, I went through the Police Academy with a goal to work for the FWC, and on first round of out of over 100 chosen, made it into the top 30% and only 3 were hired that year. I decided that I would continue fishing and created Trophy Taker Outdoors.

To be honest, this is the first time I have ever openly talked about Caylee and it's taken almost nine years to do so. It's not something I am comfortable discussing and is very painful. Most people I meet have no idea we have lost a child. We had friends that are no longer friends because they just don't know what to say, but people you'd never expect to ever know, have come to support us through our grief, which never ends. We will forever be grateful to these people. While I am not perfect, I own the fact that I am not the same person I was before Caylee died and yet, I am also human. Too many people pass the buck of their own mistakes. They misjudge, hurt others for no reason other than their own demented issues. Then, of course, there is life in general, which sometimes just throws you a curve ball.

HELP FOR THE HOLIDAYS

You are not alone

Holidays are often difficult for anyone who has experienced the death of someone loved. Rather than times of family togetherness, sharing and thanksgiving, holidays can bring feelings of sadness, loss and emptiness.

Love does not end with death

Since love does not end with death, holidays may result in a renewed sense of personal griefa feeling of loss unlike that experienced in the routine of daily living. Society encourages you to join in the holiday spirit, but all around you the sounds, sights and smells trigger memories of the one you love has died.

No simple guidelines exist that will take away the hurt you are feeling. We hope, however, the following suggestions will help you better cope with your grief during this joyful, yet painful, time of the year. As you read through this brochure, remember that by being tolerant and compassionate with yourself, you will continue to heal in your personal grief experience.

Talk about your grief

During the holiday season, don't be afraid to express your feelings of grief. Ignoring your grief won't make the pain go away and talking about it openly often makes you feel better. Find caring friends and relatives who will listen - without judging you. They will help make you feel understood.

Be tolerant of your physical or psychological limits

Feelings of loss will probably leave you fatigued. Your low energy level may naturally slow you down. Respect what your body and mind are telling you. And lower your own expectations about being at your peak during the holiday season.

Eliminate unnecessary stress

You may already feel stressed so don't over-extend yourself. Avoid isolating yourself, but be sure to recognize the need to have special time for yourself. Realize also that merely "keeping busy" won't distract you from your grief Experience suggests that it only increases stress and postpones the need to talk out thoughts and feelings related to your grief

Be with supportive, comforting people

Identify those friends and relatives who understand that the holiday season can increase your sense of loss and who will allow you to talk openly about your feelings. Find those persons who encourage you to be yourself and accept your feelings -both happy and sad.

Mention the name of the person who has died Include the person's name in your holiday conservation. If you are able to talk candidly, other people are more likely to recognize your need to remember that special person who was an important part of your life.

Do what is right for you during the holidays

Well-meaning friends and family often try to prescribe what is good for you during the holidays, instead of going along with their plans, focus on what you personally want to do. Discuss your wishes with a caring, trusted friend. Talking about these wishes will help you to clarify what it is you want to do during the holidays. As you become aware of your needs, share them with your friends and family.

Express your faith

During the holidays, you may find a renewed sense of faith or discover a new set of beliefs. Associate with people who understand and respect your need to talk about these beliefs. If you faith is important, you may want to attend a holiday service or special religious ceremony.

Plan ahead for family gatherings

Decide the family traditions you want to continue, and the new ones you would like to begin following the death of someone loved. Structure your holiday time. This will help you anticipate activities, rather than just reacting to whatever happens. Getting caught off guard can create feelings of panic, fear and anxiety during a time of the year when your feelings of grief are already heightened. As you make your plans, however, leave room to change them if you feel it is appropriate.

Embrace your treasure of memories

Memories are one of the legacies that exist after the death of someone loved. And holidays always make you think about times past. Instead of ignoring these memo- ries, share them with your family and friends. Keep in mind that memories are tinged with both happiness and sadness. If your memories bring laughter, smile. If your memories bring sadness, then it's all right to cry. Memories that were made i~ love - no one can ever take them away from you.

Renew your resources for living

Spend time thinking about the meaning and purpose of your life. The death of one loved creates opportunities for taking inventory of your life - past, present and future. The combination of a holiday and a loss naturally results in looking inward and assessing your individual situation. Make the best use of this time to define the positive things in life that surround you.

As you **approach the holidays, remember: grief is both a necessity and a privilege.** It comes as a result of giving and receiving love. Don't let anyone take your grief away. Love yourself Be patient with yourself. And allow yourself to be surrounded by loving, caring people.
