The Christmas Box Angel Statue was introduced to the world in the book *The Christmas Box*, a worldwide bestseller and hit television movie by author Richard Paul Evans. In the book, a woman mourns the loss of her child at the base of an angel monument. Though the story is mostly fiction, the angel monument once existed but is speculated to have been destroyed.

The new angel statue was commissioned by Richard Paul Evans, in response to reports that grieving parents were seeking out the angel as a place to grieve and heal. The monument was dedicated on December 6, 1994—corresponding with the date of the child's death in *The Christmas Box*.

Flowers, adorn the base of the monument year round, accompanying notes left by parents for their "little angels." On December 6th of each year a candlelight healing ceremony is held at the base of each Christmas Box Angel monument.

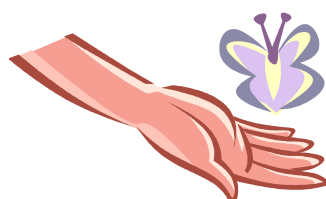

## Grieving Through the Years: A Bereaved Mother's Story

It all began ten years ago when a heart-wrenching telephone call plunged my family and me into the ranks of bereaved parents and siblings. Our 21-year-old daughter, Candice, had been in a horrible car accident, which took her life. She had decided to travel to the Dominican Republic to spend a year serving as a missionary. Less than three months following her arrival, her car was hit by some construction equipment driven by an unlicensed construction worker.

I experienced so many feelings and experiences in the early days of acute grief. Not only was it unreal, but the excruciating pain was like nothing I'd ever felt. My thoughts about her and our life together brought buckets of tears. I thought it was never going to stop hurting. I could not remember anything, including the name of the street leading to my house. I was so disorganized—starting one task after another and never completing anything. Concentration was nonexistent. I would read and reread every line and still could not remember what I had read one sentence later. I also had many fears about everything and everybody. I was especially afraid for our surviving son; he might die also. I didn't want to let him out of my sight. He pleaded with me to stop worrying so much. O yes, the death-wish was also real in the early days. I did not want live without Kandy. It was only through the realization of the additional pain my death would cause our son that I decided to try to live. For a while I was angry with my daughter for dying. How could she just go off and leave us—didn't she know we would be devastated? I was also angry at the world for continuing to move on. Didn't the world know my daughter had died?

I have learned to cope with our daughter's death by working very hard at it. Initially, I read every book I could find about grief and loss—especially those written by bereaved parents. And I joined a support group—The Compassionate Friends. After approximately two years of support from the group, I became more active and began to reach out to other bereaved parents. Three years later I established a local chapter of TCF in the District of Columbia.

In my personal life, my focus has been to keep Kandy's memory alive. One of the first ways we accomplished that was to establish a scholarship in her memory. This has been tremendously therapeutic for my husband and me. We now have eight Candice M Ruff scholars who are all recipients of the scholarship. Annually, we share the wonderful memories of our daughter with these young people.

I continue to grieve the death of my daughter years later, but it is not the acute grief I experience those first years. It is now more like a constant dull ache that is always there, no matter how hard I try to ignore it. Some days I can almost forget about it, but not for long. Her absence is always there.

Have I healed, found closure, and resolved her death? I like to think that I am in the process of healing. I refer to it as "retrospective healing" because it has been very subtle. It is only in retrospect that I can see the tremendous amount of healing that has indeed occurred. It is also active healing, where I have had to take active steps to initiate and maintain the healing process. I have found that time alone does not promote healing.

Yes, I continue to think of my child, all the time. I never think, "Oh, I am still grieving." I do notice how much it still hurts. Sometimes when I laugh it is almost an effort to do more than pay lip service to being happy. Grief is always there hovering in the shadows, waiting to rear its ugly head. For instance, I attended a wedding of a dear friend's daughter. I survived the ceremony but grief set in and I cried the entire reception. One author has referred to this kind of grief experience as shadow grief and another calls it a grief attack. Although I am never without missing my daughter, ten years later, I have found peace. I am not the same person I was prior to Kandy's death; I have changed in so many ways. I cry at different things—like weddings, or a song that reminds me of our daughter.

And now I find that I get impatient when hearing adults talk about petty events. I have found satisfaction in keeping her memory alive. I talk about her whenever I have the opportunity. In addition to the annual scholarship, I periodically hold a memorial birthday party. I write about my grief journey, and have arranged to have a memory quilt made that depicts her life in her T-shirts and photos. Finally, I planned and implemented a grief and loss seminar for nursing students at Howard University. In one year the seminar has grown from 5 to 22 students. It has now been offered for three years and 152 students have completed the course. My students give numerous testimonials of how beneficial the course has been to them personally. These activities have not only been therapeutic for me but also beneficial to others.

For now my life's work focuses on providing support and education during bereavement. I have accepted the fact that I am a different, but not necessarily better person now. The "new me" is continuing to evolve. I know that I am getting better because I don't hurt as badly or for as long a time. My crying episodes, when they occur, are short-lived. I don't believe I have completely healed nor do I feel I will ever completely heal.

"Closure" and "resolution" are not terms I use in relation to grief in my daughter's death. I will never have closure. I will always miss her physical presence. I have reached a point, though, where life is good again. Reaching out to other bereaved families, especially those grieving the loss of a child, has been a big part of that.

## It Begins With Halloween ...

The holidays can be nightmares in the making for parents who have buried their baby. After all, most holidays are geared toward children, children who are no longer here with us. We may not have other living children to carry on the celebration with, or we may be unable to emotionally do so if there are other children.

The period most dreaded begins with Halloween and runs through the New Year. I remember wishing that I could go to sleep on October 30th and not wake up until January 3rd or 4th.

Realistically, we all know that this is not a possibility. So, what can a hurting parent do to survive these days that can bring us so much pain?

To begin with, be gentle with yourself, your spouse or significant other and any surviving children. Talk to each other. Find out what each is feeling before making any decisions as to what you will or will not do.

If surviving children are too young to really know what's going on, then they probably will not miss out if you decide to not put up a tree.

Even older children may need to downplay the first holidays after losing a baby sister or brother, and are uncomfortable telling their already hurting parents. Once you and your immediate family decide what is right, you then tell the extended family what has been decided. Do not allow others to pressure you into doing something that is not comfortable.

I know from experience and from speaking with many other hurting moms and dads that often our anticipation of the holiday is worse than the actual day itself. This is especially true if you have given the days ahead a lot of thought and have decided on a plan of what you would like to try to do. There are many ways to include your baby into your holiday plans. Some ideas I have used and heard of are:

•Buying and decorating a balled Christmas tree. That tree can later be planted in honor of your baby.



- Ordering special flowers to place in a special spot in your house or to carry with you to other houses as you go.
- Decorating your baby's grave and visiting the grave before or after the day's activity.
- Dedicating the altar flowers at your place of worship in your baby's name.
- Donating gifts that you would have bought for your child to a needy child. (Many parents have found a special peace by being able to go out and actually buy the special things for their children that they had been planning on all along, then pass them on to another child whose Christmas may not have been as special otherwise.)
- Lighting a candle or placing an ornament on a tree to honor your baby.
- Attending a special service dedicated to the honor of our children such as our chapter's Candlelight Ceremony.

The ideas are endless and very personal. It is important to look into your own heart and do what brings you and yours the peace you need. If you are not sure if something is right, try it out and, if it is not what you expected, then next year try something else.

I know if I look hard enough in my heart, I usually will find what I need to do for my boys, Jonathan and Jacob.

I will light a candle this year as I do every year in honor and celebration of all our children. I will say a special prayer for you and as always my wish for you is peace, hope and love in the days ahead.
